Memberships

A. Regular Membership

Regular membership is available to individuals wishing to participate in golf, tennis, clubhouse and pool activities. Regular members are responsible for all assessments.

Regular members have the following rights:

1. Memberships are not refundable.
2. Members can serve on the Board of Directors
3. Members have voting rights.
4. Members cannot sell their membership.
5. Members cannot transfer their membership

\$40 per month food minimum

B. Non-Resident

Non-Resident memberships are available to individuals wishing to participate in the golf, tennis, and clubhouse activities of Milledgeville Country Club. A Non-Resident will be classified as anyone who has a permanent residence which lies outside of a 35 mile radius from the Club. A Non-Resident membership has no equity and cannot vote or hold office on the Board of Directors. Non-Resident members are responsible for all assessments.

Non-Resident members have the following rights:

1. Memberships are not refundable.
2. Members cannot serve on the Board of Directors
3. Members have no voting rights.
4. Members cannot sell their membership.
5. Members cannot transfer their membership.
6. Members have no food minimums.

Members must pay cart fee

C. Junior Membership

A Junior Membership is available to individuals between 18 and 35 years of age. Members may participate in golf, tennis, clubhouse and pool activities. Monthly dues will be \$100.00; fees will be the same as regular members. Upon the members 36th birthday, Junior members may change their membership to Regular or Non-Resident. Junior members have the following rights:

1. Memberships are not refundable.
2. Members cannot serve on the Board of Directors.
3. Members have no voting rights.
4. Members cannot sell their membership.
5. Members cannot transfer their membership.
